This procedure is reviewed and updated annually to ensure that appeals against internal assessment decisions (centre-assessed marks) at St Francis of Assisi Catholic College are managed in accordance with current requirements and regulations in the following JCQ documents: **General Regulations for Approved Centres** (5.3, 5.7), **Instructions for conducting non-examination assessments** (4.6, 6.1, 9) and **Instructions for conducting coursework** (6, 7, 13.5). This procedure is also informed by the JCQ documents **Review of marking (centre assessed marks) suggested template for centres, Notice to Centres - Informing candidates of their centre assessed marks and Suspected Malpractice: Policies and Procedures** (3.3, 4.5, Form JCQ/M1).

Introduction

Certain qualifications contain components/units of non-examination assessment, controlled assessment and/or coursework which are internally assessed (marked) by centres and internally reviewed/standardised. The marks awarded (the internal assessment decisions) which contribute to the final grade of the qualification are then submitted by the deadline set by the awarding body for external moderation.

The moderation process carried out by the awarding body may result in a mark change, either upwards or downwards, even after an internal review. The internal review process is in place to ensure consistency of marking within the centre, whereas moderation by the awarding body ensures that the centre's marking is in line with national standards. The mark submitted to the awarding body is subject to change and should, therefore, be considered provisional.

The qualifications delivered at St Francis of Assisi Catholic College containing internally assessed components or units are:

• GCSE, GCE, Applied General, BTEC Nationals, BTEC AAQs, BTEC Tech Awards, Cambridge Nationals, L3 Applied Diploma and Extended Project Qualification.

Purpose of the procedure

The purpose of this procedure is to confirm the arrangements at St Francis of Assisi Catholic College for dealing with appeals relating to internal assessment decisions.

This procedure ensures compliance with JCQ regulations which state that centres must:

- have in place for inspection, that must be reviewed and updated annually, a written internal appeals
 procedure relating to internal assessment decisions and to ensure that details of this procedure are
 communicated, made widely available and accessible to all candidates
- before submitting marks to the awarding body, inform candidates of their centre-assessed marks and allow a candidate to request a review of the centre's marking

Principles relating to centre assessed marks

The head of centre/senior leader(s) at St Francis of Assisi Catholic College will ensure that the following principles are in place in relation to marking the work of candidates:

- A commitment to ensuring that whenever teaching staff mark candidates' work, that this is done fairly, consistently and in accordance with the awarding body's specification and subject-specific associated documents
- All centre staff follow a robust policy regarding the management of non-examination assessments
 including controlled assessments and coursework which details the procedures relating to relevant
 qualifications delivered in the centre, including the marking and quality assurance/internal standardisation
 processes which relevant teaching staff are required to follow
- Candidates' work will be marked by staff who have appropriate knowledge, understanding and skill, and who have been trained in this activity and do not have any potential conflicts of interest (If AI tools have been used to assist in the marking of candidates' work, they will not be the sole marker)
- A commitment to ensuring that work produced by candidates is authenticated in line with the requirements of the awarding body (Where more than one subject teacher/tutor is involved in marking candidates' work, internal moderation and standardisation will ensure consistency of marking)
- On being informed of their centre-assessed marks, if a candidate believes that the above procedures were
 not followed in relation to the marking of their work, or that the assessor has not properly applied the
 marking standards to the marking, then the candidate may make use of the appeals procedure below to
 consider whether to request a review of the centre's marking

Additional centre-specific principles:

Candidates must be able to present evidence to support their appeal, speculative appeals or those which question academic judgement will not be accepted.

Procedure for appealing internal assessment decisions (centre-assessed marks)

The head of centre/senior leader(s) at St Francis of Assisi Catholic College will:

- Ensure that candidates are informed of their centre-assessed marks so that they may request a review of the centre's marking before marks are submitted to the awarding body
- Inform candidates that they will need to explain on what grounds they wish to request a review of an internally assessed mark as a review will only focus on the quality of work submitted
- Inform candidates that they may request copies of materials (as a minimum, a copy of the marked assessment material (work) and the mark scheme or assessment criteria plus additional materials which may vary from subject to subject) to assist them in considering whether to request a review of the centre's marking of the assessment
- Having received a request for copies of materials, promptly make them available to the candidate (this will
 either be the originals viewed under supervised conditions or copies) within the period of time as specified
 (see **Deadlines** below)
- Provide candidates with sufficient time to allow them to review copies of materials and reach a
 decision, informing candidates that if their decision is to request a review they will need to explain what
- Provide a clear deadline for candidates to submit a request for a review of the centre's marking and confirm understanding that requests must be made in writing and will not be accepted after this deadline (see **Deadlines** below)
- Require candidates to make requests for a review of centre marking by completing an internal appeals form.
- Allow sufficient time for the review to be carried out, to make any necessary changes to marks and to
 inform the candidate of the outcome, all before the awarding body's deadline for the submission of marks
 (see **Deadlines** below)
- Ensure that the review of marking is conducted by an assessor who has appropriate competence, has had no previous involvement in the assessment of that candidate for the component in question and has no personal interest in the outcome of the review
- Instruct the reviewer to ensure that the candidate's mark is consistent with the standard set by the centre
- · Inform the candidate in writing of the outcome of the review of the centre's marking
- Ensure the outcome of the review of the centre's marking is made known to the head of centre who will have the final decision if there is any disagreement on the mark to be submitted to the awarding body
- · Ensure a written record of the review is kept and made available to the awarding body upon request
- Ensure the awarding body is informed if the centre does not accept the outcome of a review

Candidates will be informed of their centre assessed marks prior to the awarding body deadline. Candidates must be able to present evidence to support their appeal, speculative appeals or those which question academic judgement will not be accepted.

Appeals against decisions to reject a candidate's work on the grounds of malpractice

The JCQ **Information for candidates' documents** (Coursework, Non-examination assessments, Social media) which are distributed to all candidates prior to assessments taking place, inform candidates of the things they must and must not do when they are completing their work.

The centre ensures that staff delivering/assessing coursework, internal assessments and/or non-examination assessments are aware of centre procedures relating to the authentication of learner work and have robust processes in place for identifying and reporting plagiarism (including AI misuse) and other potential candidate malpractice.

Candidate malpractice offences relating to the content of work (i.e. inappropriate/offensive content, copying/collusion, plagiarism (including AI misuse) and/or false declaration of authentication) which are discovered in a controlled assessment, coursework or non-examination assessment component prior to the candidate signing the declaration of authentication do not need to be reported to the awarding body but will be dealt with in accordance with the centre's internal procedures.

If there are doubts about the authenticity of the work of a candidate or irregularities are identified in a candidate's work before the candidate has signed the declaration of authentication/authentication statement (where required) and malpractice is suspected, St Francis of Assisi Catholic College will:

Follow the authentication procedures and/or malpractice instructions in the relevant JCQ document (Instructons for conducting non-examination assessments / Instructions for conducting coursework) and any supplementary guidance that may be provided by the awarding body. Where this may lead to the decision to not accept the candidate's work for assessment or to reject a candidate's coursework on the grounds of malpractice, the affected candidate will be informed of the decision.

If a candidate who is the subject of the decision disagrees with the decision:

a written request, setting out as clearly and concisely as possible the grounds for the appeal, including any further evidence relevant to supporting the appeal, should be submitted. An internal appeals form should be completed and submitted within two working days of the decision being made known to the appellant.

The appellant will be informed of the outcome of the appeal:

• within five calendar days of the appeal being received and logged by the centre.

Deadlines and timescales

- Upon request, copies of materials will be made available to the candidate within three working days.
- The deadline to request a review of marking must be made within two working days of the candidate receiving copies of the requested materials.
- The process for completing the review, making any changes to marks and informing the candidate of the outcome must be complete before the awarding body's deadline for the submission of marks. Deadlines and timescales may adjust accordingly to accommodate this process.
